Greetings from the TTNC Board

Greetings to everyone reading the second edition of the TTNC Newsletter! According to numerology, 2013 should be a good year. As always with new beginnings, there is also a review of what has been accomplished during the last year. We held our second TTNC AGM on November 13, 2012 via Skype conference call. Here's a snapshot of our previous year.

Accomplishments:

- Job descriptions for the president, treasurer, and secretary TTNC Board positions were developed.
- A policy on the rotation of board officers was developed.
- A Code of Ethics and Conduct for TTNC directors and committee members was developed.
- Monthly financial statements were prepared and year-end statements were reviewed by an independent accountant.
- An annual report to Corporations Canada was submitted.
- A commitment from each network to provide TTNC with \$1.00 per member annually was renewed.
- Links to TTNC were placed on various websites including: all the Canadian networks represented by TTNC, the Canadian Holistic Nurses Association, and the Therapeutic Touch International Association (TTIA).

Goals for the year were developed and prioritized. The top three goals identified were: Development of a national newsletter. Investigation into the possibility of having Therapeutic Touch[™] sessions being covered by insurance companies. Development of an equivalency for Therapeutic Touch teaching curriculum between Canadian networks.

Work in Progress/Ongoing:

- TTNC has worked with TTNO to monitor the application of the French Therapeutic Touch trademark, providing further information to the government upon request.
- Several discussions have taken place with the Manitoba network to ascertain if there are ways we can support them, and we have provided encouragement to them to join TTNC.
- We are having discussions with various organizations, including the Canadian Holistic Nurses Association and TTIA.

Future Goals:

- We will support member networks to foster the growth of Therapeutic Touch and their memberships.
- The Board of TTNC continues to develop and clarify our vision and mission so as to respond to the needs of the regional networks we represent. Input from the regional boards is very much appreciated. With their input, we will again be strategizing our goals and priorities for this year.
- We will continue to develop operational policies and procedures to aid in the smooth running of TTNC.
- We will continue to support our current committees:
 - Brita Ball, TTNO, is coordinating the e-newsletter. With submissions from across Canada, it is already successful and will be evolving with each edition. The e-newsletter committee is currently developing Terms of Reference and clarifying roles and responsibilities. We look forward to your continued support and involvement.
 - Barbara Stone, ATTN, is coordinating the committee that will be setting the standards for teaching Therapeutic Touch in Canada. The representatives from the five networks are well-qualified to help guide this project. They are currently collecting all the curriculae from the various networks and will begin reviewing them in the very near future.
 - Leo Gregory, TTNQ, is coordinating the brochure committee. They have been gathering samples of brochures from teachers, practitioners, networks, etc. to learn how Therapeutic Touch is being described and advertised. Thanks to all who have already sent in sample brochures and advertising on workshops and practice nights. They have created a private, committee only, Brochure Group in LinkedIn where all the documents are reviewed and suggestions for improvements are made on a page-by-page basis. Success with all these projects depends on the ability to communicate with each other. The technology available today is very instrumental in the progress of some of our initiatives. We thank all of our volunteers for their expertise, commitment and efforts. *Cheryl Larden*

Practice Gift from your TTNQ Network

Beginning January 2013, all practice groups in Montreal (n.d.g., South Shore, West Island) are offering those people who attend a special benefit—free membership for 2014!

The membership fees, which are \$40 a year, can now be discounted depending on how many practice nights you attend. Using eight months a year x \$5 = \$40. Each practice night will cost \$5. You may accumulate enough money to pay for your next year's membership.

For example, if you attend four practice nights in 2013 (at \$5

a night), your total is \$20. The discount on your membership for 2014 is \$20. Therefore, you pay only \$20 for 2014.

We wish to encourage those people who attend practice groups and help with their membership costs. The discount months are January, February, March, April, May, June, September, and October. November will cost \$5 to attend, but the money will be used to pay for TTNQ to tally your discounts and for administration fees.

The Therapeutic Touch Network of Ontario (TTNO)

A recent meeting between the TTNO Board and myself explored some interesting and perhaps unique aspects of the TTNO's relationship to the TTNC's newsletter. TTNO's **in touch** is sent to all regions, and members recently received the Winter/12 issue with details of Ontario 'happenings'. Thus, TTNO chair, Jane Graham, asked if I would do a review of Ontario activities for this newsletter.

Ontario's Annual General Meeting/Fall Event was held at the end of October at a delightful resort at the East end of Lake Ontario. Rainy weather failed to dampen the loving, welcoming and enthusiastic Therapeutic Touch family reunion. Enthusiastic feedback means that we will be repeating this format in 2013 in Barrie, ON.

Early in 2012, we facilitated fifteen Focus Group consultations across Ontario. The intention was to 'hear' our members and gain insight and knowledge about who we are as a network. We wanted to gather facts and identify trends, needs and opportunities in order to inform future directions of the TTNO. What we discovered in the process shows a healthy and dynamic organization—one with clear values, standards of practice, growing confidence and ideas that can take us forward.

We were impressed with the diversity, strength and commitment of our scattered groups. Some individuals felt strongly connected to their Practice Group rather than to the larger TTNO. Some groups felt connected with the TTNO; others saw themselves as independent, functioning on their own without much interaction with TTNO. One member used the delightful analogy that the TTNO is the body, Practice Groups are the organs, and the Members are the cells; they are all important in relation to each other. A priority for the coming year is implementing strategies to encourage our members to remain with us, as well as attracting new members.

A TTNO "Communications Toolkit" has been developed for use by members in presentations to groups and at health fairs. We are building a database of contacts and agencies interested in having Therapeutic Touch presented at special events, health fairs or conferences.

Bookworm's Food for Thought



Spreading the Word!

When I was a student nurse many years ago, I read a book by Dr. Krieger and Dora Kunz, but it was early days in the Maritimes for Therapeutic Touch[™], and my classmates looked at me as if I had three heads when I tried to share information.

The timing must have been right 22 years later, during my healing journey from breast cancer, as I discovered through the PEI Breast Cancer Support Group that a Therapeutic Touch class was to be taught by Evelyn Mitchell (2002). I have been involved ever since in a variety of ways.

As a member of the CBCN (Canadian Breast Cancer Network) Board of Directors, I attended the Canadian Medical Association-sponsored gathering titled, "Innovating Together: Patient Forum on Health Care Transformation", Dec. 3, 2012 in Toronto.

A variety of speakers from Public Health to the University of Toronto spoke, as well as Sharon Baxter, Executive Director of Canadian Hospice Palliative Care Association.

I was pleased to have the opportunity to communicate to the entire group of participants (50), the difference between alternative health care and the term "complementary" or "integrative" health care, as the latter can include the modality we practice!

The Montana Dialogues 2012 - Reporting Back

The Montana dialogues are held each August for ten days in Columbia Falls, Montana, near the home of Dolores (Dee) Krieger. August 2012 was the third year of the Dialogues. Dee has a vision "that ultimately in dialoguing…working together as one mind, the input from all will grow into a coherent whole leading to a basic theory of healing, a human understanding of a process driven by universal law."

Dee has approached developing a theory of healing from two directions. The "Knowing Project" focuses on the experiential knowledge that wells up in the Therapeutic Touch[™] practitioner during the healing moment. Dee is getting information for this project from the grass roots, through two projects: the "Looking Over Your Own Shoulder During Therapeutic Touch Sessions" study (2011) and the Distant Therapeutic Touch Study (2012). Work collated from the 2011 study has already been written up in an article that is still undergoing peer review. The Distant Therapeutic Touch study results will be collated this winter. She has two stalwart helpers in this huge endeavour, Pat Cole and Sandy Matheny. These two incredible people also help to organize the Montana dialogues.

The logic-bound "Seeking Project" is designed to analyse the variables important to the Therapeutic Touch practitioner's engagement, leading to the development of a Theory of Healing. Mary Anne Hanley, from Texas, plays a leading role in this project, helping Dee by compiling the work that we do in small groups over the ten days we share in Montana. This is no small feat!

Why do we need a theory of healing? Healing has been a constant for more than 10,000 years, yet we still have no understanding of what makes it work. It is done on the basis of belief and experience. Healers have recognized that:

- We don't fit in with the rest of the world.
- What we do is invisible to most people in the world.
- We don't have the language to describe what we do.
- We can't explain how what we do works.

A theory of healing will answer the need to be able to explain what we do to the rest of the world and allow us to take our rightful place in the future.

This theory is not going to change how we do our Therapeutic Touch, but it will change our understanding of Therapeutic Touch and, with understanding, comes deeper work and more profound experiences. It will also allow us to explain what we do in a clearer way and to begin to do research on healing itself at a different level. Research has changed since the findings on quantum theory discovered that the observer changes the results of what is being observed. This observation casts a whole new light on research methodology and calls into question the whole scientific method. We don't know where research is going, just that it is changing, and with a theory in place we can begin to research how healing works.

This year, in Montana, we talked about the results of the "Looking Over Your Own Shoulder During Therapeutic Touch Sessions" project. All respondents noted that the heart chakra was involved immediately during their centering and noted also their own hand/heart chakra connection.

Dee talked about compassion as being the transformational aspect of Therapeutic Touch. As we engage in acts of compassion, we strengthen the link to our inner self. As well, it is transformational for our healing partners. They see the compassion in us. We have an "aura" about us, a healing presence, and they want that for themselves. They realize that they too can have that sense of peace, and begin to change their lives.

"Without compassion, whatever else one may do, it is not Therapeutic Touch." (Dolores Krieger. <u>Therapeutic Touch as</u> <u>Transpersonal Healing</u>, page 85)

Common to all respondents was the recognition of stillness. As we worked, we found that we entered a state of altered consciousness, beyond the space/time continuum. The crown chakra was engaged along with the throat and third eye chakras. We reached a place of stillness where we connected to our inner self so deeply that we stepped aside and found the true meaning of the term "effortless effort". It was no longer about "doing", but about "being". One of our members used the term "hovering".

As the Dalai Lama says, "Something is touched in sharing deep silence together that words alone can only point to but never express." (Dalai Lama. <u>The Good Heart</u>, Introduction)

I urge you all to do the "Looking Over My Own Shoulder" exercise. Email me at <u>adcooke@xplornet.com</u> if you would like a copy of the exercise. It will take you deeper into understanding your own process. Share your findings in your Practice Group so that, together, you come to a deeper understanding of the experience of Therapeutic Touch.

One Practice Group facilitator asked me to bring my 2012 AGM talk to her Practice Group. If any other groups would like to hear my talk about my Montana experiences, I would be happy to bring it to your group. I plan to use these visits as a fundraiser for the TTNO, so I will be asking for donations from those who attend.

As always, my thanks go to the TTNO for supporting me in my travels to Montana by paying a portion of my costs.

What's in a Name?

In the mid 1980s, Crystal Hawk and I were discussing what to call the Therapeutic Touch[™] organization we were developing. At that time, we were impressed with the recently published "Decide to" writings. So, we chose the name "Network", and as you read the following, you will understand why.

Decide to network...

Use every letter you write Every conversation you have Every meeting you attend To express your fundamental beliefs and dreams Affirm to others the vision of the world you want

> Network through thought Network through action Network through love Network through the spirit

You are the center of a network You are the center of the world You are a free, immensely powerful source of life and goodness

Affirm it Spread it Radiate it Think day and night about it

And you will see a miracle happen: the Greatness of your own life In a world of big powers, media, and monopolies But of six billion individuals Networking is the new freedom the new democracy A new form of happiness

This so clearly described our intent to "affirm to others the vision of Therapeutic Touch you want", and it remains relevant today as we go about our lives, which have been so enhanced by this life path. As we participate in our local Practice Groups, it might be worthwhile giving "Decide to Network" as a handout, then reading and discussing it line by line. As we think now of ourselves as a Canadian entity—and one of several national Therapeutic Touch organizations—we can begin to understand what a valuable exercise this could be!

I have recently been concerned about the 'business networking meetings', which consist of rather aggressively getting others to know your business and getting 'leads'. As I gave this some serious thought, however, I realized that many of us could learn a thing or two about promotion. So many of our colleagues are shy, quiet souls who carefully avoid 'standing on our hind legs' and declaring Therapeutic Touch to our world!

Part of this reticence stems from our fear of being challenged or disrespected—which certainly can happen—but this fear can be considerably reduced by some simple measures.

- Carry Therapeutic Touch brochures with you at all times. The TTNC is currently designing one that will be available online and can be easily printed or ordered.
- Learn a definition of Therapeutic Touch so simple that a child can understand it.
- Share with others through your Group and this newsletter how you have personally networked Therapeutic Touch. You'll inspire others to do the same!

Professional Liability Insurance

Did You Know...

Some of our members were looking for low-cost insurance. The Therapeutic Touch Networks of Canada (TTNC) have worked with BFL Canada Risk and Insurance Services Inc. to put together a package in which some of you may be interested.

When does the new term begin?

The new term is from December 1, 2012 – November 30, 2013. There will be a flat rate for the year regardless of when you sign up, i.e. the policy will not be prorated.

What's covered?

You are covered for Professional Liability coverage up to \$2,000,000.00. You will also have Commercial General Liability coverage, which includes bodily injury, property damage, personal injury, advertising injury, medical payments, tenant's legal liability, non-owned automotive liability, and damage to hired automobiles.

What about coverage for other modalities I do?

Since many practitioners practice more than one modality, a secondary optional package can be purchased for coverage of the following : acupressure, aromatherapy, crystal healing, energy work, raindrop therapy, sound therapy, hydrotherapy, Reiki, qigong (rhythmic breathing), reflexology, polarity therapy, Healing Touch, iridology, and colour therapy.

What's the cost?

This current year, the fees have been set at \$125.00 per year, which gives the practitioner the above coverage as a Therapeutic Touch[™] Practitioner. This is available to members only. The additional, optional package, which covers others modalities, is available for an additional \$60.00 per year, plus taxes. Members report that other insurance companies are charging up to \$800.00 per year for comparable coverage.

Even though our participation has been lower than anticipated, BFL Canada Risk and Insurance Services Inc. has agreed to keep the same rates as last year!

Why do I need insurance?

Whether you get the insurance or not is up to you. People who volunteer in hospitals or hospices may have some insurance coverage when doing Therapeutic Touch in that facility. BFL insurance may provide additional coverage.

Some agencies are asking volunteers if they have their own coverage. As an example, many Therapeutic Touch practitioners used to volunteer at the Vancouver Sun Run (a large cancer fundraiser). Now, insurance is required in order to be a volunteer.

If you have your own business, most would agree that it just makes sense. Even if you did nothing wrong, it often costs money to defend yourself against any claims.

I'm still not sure if I want this insurance and if it fits my needs.

You need to decide for yourself if this insurance is for you. For a more complete description of what this insurance covers, premiums, etc. please look at the TTNC website: <u>www.ttnc.ca</u>, under insurance coverage. The application forms can also be found there.
